AGENDA FOR THE CITY OF CREOLA COUNCIL MEETING HELD AT CREOLA CITY HALL ON April 25, 2013 @ 6:00PM

Mayor called the meeting to order. Rev. Chambers gave invocation. Upon the call of roll, the following were found to be present:

Mayor Nelson Councilwoman Greene Councilman Heathcoe Councilman Ivy Councilman Howell Councilman Moss was absent.

City Clerk was absent.

Mayor asked to keep Councilman Moss in prayer.

Minutes from the council meeting held on April 9, 2013. Councilman Ivy made a motion to accept the minutes from the last meeting held. Councilwoman Heathcoe seconded, all favored, none opposed, motion carried.

CITIZENS ADDRESSING THE COUNCIL

Ms. Linda Robinson, Dr. Walters and Jimmy Vaton with the Satsuma School system were present at the meeting. On behalf of the Satsuma School board, Ms. Robinson addressed the citizens and states that they are concerned about the Creola children. Ms. Robinson states that they are available for questions to address any concerns. Mr. Vaton followed talking about future goals of the system.

Mayor addressed letter that was posted in the city by Mayor of Satsuma. Mayor states that he did speak with the Mayor elect at the time. Mayor Nelson states that they did speak about the annexation but Mayor Nelson states that he said then as well as know that it is the citizen's decision as well as the council and that was it. Mayor states that the annexation of Creola with any city has not come to the council floor to be discussed. Mayor opened floor for questions and

comments about the letter from Satsuma. Mayor asked Ms. Peak about building a High school in the area and she said that a high would not be built in this area.

Mayor states that in Jan of 2013, citizens asked the Mayor to check into setting up a meeting with the Saraland School system. Mayor states within 60 days there should be a meeting with Saraland School system and if the citizens would like to attend there would have to be annexation involved. Mayor states that this council has not addressed any annexation with any city. Mayor states that the only reason he sits on this council is to do what is in the best interest of the citizens.

Councilman Howell states he was insulted by this letter. Councilman Howell states he has not met with any councilmember from Satsuma.

- *Mrs. Knight states would like to know where our kids stand in all this.
- *Mrs. Nichols would like a meeting with both school boards and council needs to call for election.
- * Mrs. Lister states that the citizens need to closely examine annexation because it is more than sending your children to school it would consist of more taxes,etc.
 - *Mrs. Bennet states that North Mobile School is a great school. Mrs. Bennet spoke well of Creola police department.
 - *Councilwoman Greene asked about a petition going around the city.
 - *Mrs. Dingman states that if you want your child to go to another school than you have an option to do so by paying tuition but she does not want to lose that small town feeling.
 - *Mrs. Bryant states that our town is not growing so we have to do something.
 - * Mrs. Kruger states that we have a beautiful school in our area.
 - *Rev. Chambers states that there is room at the school on Salco to add a building for High school.
 - * Mrs. Smith would like to see if the school system can offer something for our kids without annexation.

Citizens asked the Mayor to have a meeting with Mobile county school system to ask questions. Mayor thanked everyone for voicing their opinions.
