Mayor states that they have to do research to see if it is or is not. Councilwoman Greene states that the road will have to be probated. Mayor states that it will not happen overnight.

A citizen states he lives on Lyons Drive, and the road is damaging his vehicle and the people are coming are tearing his property up by driving in his yard to keep from driving in the big holes on the road. It is a green sign on this road. Mayor states that they will check into seeing if the roads are private or public.

Mrs. Janice Tarver asked what about all the petitions that they have signed to come into the city. Mayor states that the petitions had nothing to do with the roads, by signing the petition that was to bring your land into the city. Mrs. Tarver states that the road should be included. The attorney states that the road is a dedicated street.

Mrs. Tarver asked about getting slag put on Lyons, Hall and Hurst up to Ducey just to help out on those roads being they are public roads. Mayor states that they are checking into the roads to see what can be done. Mayor states that if they found out that the streets are public then they can put slag on it.

Mrs. Odom asked where to go to see if Lyons Road is public or probate. Mayor states to go to Probate court.
