AGENDA FOR THE CITY OF CREOLA COUNCIL MEETING HELD AT CREOLA CITY HALL ON March 26, 2015 @ 6:00pm

Mayor Pro-tem Ivy called the meeting to order Chief Taylor gave invocation. Pledge of Allegiance Upon the call of roll, the following were found to be present:

City clerk was present and City attorney were present.

Councilman Heathcoe made a motion to accept the minutes from the meeting 3/12/15. Councilwoman Greene seconded, all favored, none opposed, motion carried.

CITIZENS ADDRESSING THE COUNCIL

Mr. Fisher states that he had been out of town and wanted to know if the Mayor had invited the county engineer out to discuss the road that did not get fixed properly.

Councilman Howell states that they found out that it is just a courtesy to contact the Mayor and on this project they just turned it in as finished and did not contact the Mayor.

Mr. Kenny Walker asked if the council was going to vote tonight about John Crenshaw doing the surveying job for Ducey Road

Councilman Heathcoe asked why can't they just vote and get it over with.

Mr. Walker states that he took the information to Attorney Johnny Lane to go over; and Mr. Lane said what he had is sufficient.

Councilwoman Greene states she wants to go with Mr. Crenshaw.

Councilwoman Moss states that she has spoken Mrs. Nayer Mahdi and she is coming to look at Ducey Rd and will say what needs to be done.

Councilman Howell states that they just want to make sure that they are doing the right process and after Mrs. Nayer Mahdi comes then they can schedule a special meeting.

Councilwoman Moss states that Kim can call her tomorrow and set up an appointment. Kenny states that he would like to be at the meeting and he wants everything in writing.

Councilwoman Moss asked Diane Reed if she knew if Lemoyne water had put the water lines down the middle or on the side of the road. Mrs. Diane states they did not know, but there is city water there.

PARKS AND RECREATION

Councilman Howell states that the entire disc golf course is complete, with a total cost of about \$6200.00

Councilman Heathcoe made a motion for Councilman Howell to take Kubota tractor to friend to see what it would take to fix.

Councilwoman Greene second, 4 favored- Councilman Howell abstained, none opposed, motion carried.

Councilman Howell asked to put flyers out on May 2 for the ministerial association gathering, stating that the disc golf course will be closed until 2pm that afternoon.

Councilman Howell states that dogs are in the park running off the leash. He does not have a problem with you taking your dog to the park just clean up after your dog. Council needs to talk about it and make a decision on what to do.

Councilman Howell states that he wants NO PARKING BEYOND THIS POINT put at the park.

Councilman Howell made a motion to rearrange the post at the park and to put up no parking beyond this point signs.

Councilwoman Greene second, all favored, none opposed, motion carried.

Councilman Howell made a motion for the Landrum family reunion to be held at the pavilion on July 4.

Councilwoman Moss second, all favored, none opposed, motion carried.
