POLICE AND FIRE

Mayor updated about the loan. Mrs. Kim separated \$4500.00 from the bidding process for the fire trailer and \$4500.00 for the police charger that the council approved to sale. Mayor states that he recommends to the council that they split the money in those accounts.

Councilman Heathcoe made a motion to pay the bill for the bill for the front end loader in the amount of \$3200.00.
