A citizen states that on Creola drive the limbs need to be cut ,the grass needs to be cut and they also need someone with a back hoe to push the grass back so the water can drain. Mayor states that it will get passed on to the street department.

ADDITIONAL NOTES

Councilwoman Greene states the dogs in park cancer walk was last weekend. Councilwoman Greene thanked the city for sponsoring the event, special thanks to Platt's for donating hot dogs, chips and drinks. It was a very good day.

Councilman Ivy as citizen would like to donate a 20 ft wide by 300 ft road to the city and it has been surveyed and probated. Councilwoman Moss states that you can not take a private road into the city; it has to be a public road.

Mayor states that he spoke with Atty. Jay Ross. Councilman Ivy has had it surveyed and probated and went before zoning board and then referred back to council for a decision. The council can bring it in or reject it. This is a donation from Mr. Ivy to the city. Mayor states that Atty. Jay Ross states that it is no conflict of issue.

Councilman Howell made a motion to accept the donation of the road from Mr. Ivy. Councilman Heathcoe second,

Mrs. Cathy asked if the city was going to maintain the road. Councilman Heathcoe states that it will not be paved. Councilwoman Greene states that she does not agree with it and that all owners of property of the road should be here.
