AGENDA FOR THE CITY OF CREOLA COUNCIL MEETING HELD AT CREOLA CITY HALL ON October 27, 2016 @ 6:00pm

Mayor called the meeting to order and gave invocation.
Pledge of Allegiance
Upon the call of roll, the following were found to be present:

City clerk was present and City attorney was absent

Councilman Howell made a motion to accept the minutes from the meeting 9/22/16. Councilman Heathcoe seconded, all favored, none opposed, motion carried.

Councilman Heathcoe made a motion to accept the minutes from the meeting 10/11/16. Councilwoman Greene seconded, all favored, none opposed, motion carried.

Councilwoman Moss made a motion to accept the minutes from the meeting 10/13/16. Councilman Heathcoe seconded, all favored, none opposed, motion carried.

Councilman Howell made a motion to accept the minutes from the meeting 10/19/16. Councilwoman Moss seconded, all favored, none opposed, motion carried.

CITIZENS ADDRESSING THE COUNCIL

Mrs. Joan Stringfellow thanked Councilman Howell, Councilman Heathcoe, Councilman Ivy, and Mayor Nelson for their service in the past years.

Mr. Melvin Enzor addressed council about his road. He states he has the same as he had before and he has also went to the proper divisions (probate court) to verify that the city can take road and he also spoke with Nicole Taylor with SARPC and the city has power to accept if they choose. Mr. Enzor wants to know what the city will accept. Mayor explained rules and states that the new council would like to wait until they have legal council.

RESOLUTIONS, ORDINANCES OTHER BUSINESS

Mayor presented the 2014 audit statement and Mr. Anthony is working on the 2015 audit. Councilwoman Greene states that Pastor Ellen Lesley with St. Andres Chapel would like to get with the Creola Axis Ministerial association to present a live manger scene on December 21, 2016 in the park near pavilion. Snacks and hot chocolate will be served. Councilman Howell made a motion to use park near pavilion for live manger scene. Councilwoman Moss seconded, all favored, none opposed, motion carried.

Councilman Howell made a motion to renew the cities contract with Advance Disposal garbage service with No rate increase for 5 years.

Councilman Heathcoe second, all favored, none opposed, motion carried.

Councilwoman Greene states that with the new council coming in and the hard work put in with Advance is appreciated, she feels like this topic should wait until the new council comes in so they can talk to some new companies and offer a few options.

Councilwoman Greene states that if Advance is willing to give a good rate now they should be willing to wait about 10 more days. Councilwoman Greene states that they should talk to 3 or 4 companies to get rates for the citizens.

Councilman Howell states that there is an out on both ends of this contract and the new council can change it if they choose at that time.

Mr. Kenny Walker states that the price of the dumpsters has gone up every month. Councilman Howell states every time he has contacted Advance with a problem it was taken care of.

Mr. Kenny Walker states that the City of Creola should make it mandatory to have trash service if they live in the city.

Councilwoman Moss asked when the contract is up. Councilman Howell states that we are not under a contract at the moment.

A citizen asked what happens if a citizen does not pay their bill. Councilman Howell states that Advance disposal deals with that issue.

Councilwoman Greene asked if the council passed this contract tonight it is good for 5 years but the new council can get out of it if they want. Councilman Howell states that it is not a binding contract that it has always had an out to it. Councilwoman Greene states that she is happy with the service she just feels they owe it to the citizens to check for other rates. Councilman Howell states he will revisit the dumpster issue. Mayor states this contract is for 5 years, the city has a dumpster, community day they furnish about 20 cans, senior center and park dumpster is furnished,

Mr. Criswell states no new business. Councilwoman Greene states they discussed their plan.

PARKS AND RECREATION

Councilman Howell stated the slab was poured this week to the bathroom and starting the walls next week. Councilman Howell states he will be meeting with mobile fence tomorrow to get the final say on where to put fence between soccer field and street. The fence is being put in by Commissioner Ludgood. Councilman Howell states that Commissioner Ludgood has been an asset to the community and she has been very involved in this city. She is very much appreciated.

UTILITIES AND SENIOR CITIZEN

Councilwoman Moss states that traffic is backed up on Saturdays and maybe needs a 4 way stop at old Hwy 43 and dead lake after soccer games. Councilman Howell states that they need an officer in that area on sat during the games. Chief states that a 4 way stop would back up traffic on Dead Lake Rd. Mayor and council will look into solutions.

Mayor states that Senior center guidelines is to protecting the city by saying that the city will abide by all the department of urban development rules and regulations and abide by the City of Creola rules and regulations and by the county development grant guidelines. Councilman Howell motioned to accept sail center guidelines.

Councilman Ivy second, all favored, none opposed, motion carried.

POLICE AND FIRE
