Ms. May Brooks asked to make a presentation to the Creola PD. Mayor Criswell honored her request. Ms. Brooks, a member of "Friends of the Creola PD, stated that the Friends of Creola PD sponsored the fundraiser back in the summer, to purchase Bullet-Proof Vests for the police officers but when Councilman Martin spoke with Commissioner Ludgood, she so graciously agreed to purchase the vests for the officers.
