Mayor Criswell called the meeting to order. Mayor Criswell gave the Invocation. Pledge of Allegiance

Councilman Walker made a motion to accept the minutes of 02/28/2019, seconded by Councilwoman Moss, all favored, none opposed, motion carried.

CITIZENS ADDRESSING THE COUNCIL

RESOLUTIONS, ORDINANCES AND OTHER BUSINESS

- (1) Proclamation read by Councilwoman Moss for "Rooster" a four-legged citizen of Creola. This Jack Russell Terrier belongs to Gwen and Billy Lister, Jr. "Rooster" was recognized by Mayor Sandy Stimpson of Mobile for his participation in Mobile's Mardi Gras celebrations since he was a pup. "Rooster" is always adorned w/ his Alabama glasses and Bear Bryant cap. Mayor Criswell presented this proclamation to "Rooster" on this date, March 14, 2019.
- (2) RDS (AVENU) Contract- Councilwoman Greene reported that RDS collects the monies for taxes due the city and deposits in our general fund. Councilwoman Greene made a motion to approve renewal of the RDS contract, Councilwoman Moss seconded, all favored, none opposed, motion carried.
- (3) Resolution 2019-022-Support of protection of public streets and public access-Councilwoman Greene read the resolution tabled at last meeting and made a motion to approve this resolution, seconded by Councilwoman Moss, all favored, none opposed, motion carried. This resolution will be forwarded to Bradley Byrne, Doug Jones and Richard Shelby.
- (4) List of Bills-Attached to 3rd page of financial reports. Councilwoman Greene made a motion to pay bills, Councilwoman Moss seconded, all favored, none opposed, motion carried by roll call.
- (5) Amendment to minutes of September 28, 2018. Ordinance No. 2018-013 and Ordinance No. 2018-013A numbers were omitted from minutes. Councilwoman Greene made a motion to amend the minutes adding ordinance numbers to minutes, Councilwoman Moss seconded, all favored, none opposed, motion carried.
- (6) Councilwoman Greene stated that Ordinance 2019-19 was introduced at last meeting to annex six properties as they are continuous to other properties. The respective owners of the six properties are: Christopher Dean Vernon and April K. Vernon, Sheila J. Grimsley and Darrell Grimsley, Michael L. Davis and Sherry Davis, Trustees, Linda G. Jones and Arthur L. Davis, Jr. and Peggy Ann Bluitt. This will be advertised in the *Call News*.
- (7) ALDOT TAP Project Resolution No. 2018-019. Mayor Criswell explained that this is a grant thru SARPC for sidewalks from Crenshaw Park to Bradley Court. This is a \$390,000.00 grant and our cost will be \$75,000.00 pro-rated over a period.

Mayor Criswell announced the Senior/Veteran Breakfast will be June 1, 2019 9-11am at Creola Senior Center. This event is to recognize all Veterans and Seniors. Everyone is invited. Councilwoman Moss reported that 50-60 have be fed in the past. Councilwoman Greene made a motion to use the Senior Center for this event, Councilwoman Moss seconded, all favored, none opposed, motion carried.

BUILDING INSPECTOR

Don Moss reported that, contrary to all the rumors, trailers have been moved out. Escort fees paid. There is a red "X" on the ones to demo. Two more will be moved, one going to Montgomery and one going to Chickasaw.

Mr. Moss reported he attended the school for the 2018 Bldg. Code. Three from the class made 98 on the test. Mr. Moss being one of the three. A picture of the three will be in their magazine that will be sent to all cities. The City will be ordering the 2018 Building Code Manual, as we are now using 2015 but upgrading to 2018. We are using the 2016 Electrical Code. Under the new 2018 code all fortified roofs will get a 29% insurance savings for residents. Attorney Mims will be writing and Ordinance for the 2018 Code
