# **RESOLUTIONS, ORDINANCES AND OTHER BUSINESS**

Mayor Criswell reported that Ethics Training for Staff is underway. The city staff had 4 days of training with Alabama League. It was a very profitable meeting. Our City Attorney, Danny Mims received a plaque from ALM for 20 years as Judge in Bayou La Batre.

Councilwoman Greene made a motion for Terry Foster to use the Creola SAIL Center on June 8<sup>th</sup> for a Hunting Education Class, seconded by Councilman Hadaway, all favored, none opposed, motion carried. This class gives young people an opportunity to obtain a hunting license.

Mayor Criswell announced there will be a "Creola Clean Sweep" to be held Saturday, May 18, 2019 7am-3pm. A 30-yard dumpster will be provided by Advanced Disposal, at no cost to the citizens. The City will pay for dumping. It will be in Creola Park by the Pavilion. A flyer will be placed in all mailboxes, both rural and post office listing the Do's and Don'ts for trash. No businesses can use this service. The PWD will be on-hand to help citizens unload their debris. The 2018-2019 Flood Plan Information will be placed on the flyer, as well. These documents are available for viewing at Creola City Hall.

#### POLICE

Brother John White reported that we have 3 new officers in the Academy and 1 new hire. A requisition has been submitted to Mobile County Personnel Board for 2 supervisors. We are trying to entice new officers. We are now competitive with the COLA in effect. Councilwoman Moss asked about recruiting retired officers. Mayor Criswell explained that we must be careful as their retirement with RSA could be in jeopardy. They would only be allowed to make a maximum amount and still draw their retirement. John White explained other issues with hiring retiring officers.

#### FIRE

Chief Jeff Reeves reported that he has an estimate for Engine #3 repairs. A motion was made by Councilman Hadaway to repair Engine #3, not to exceed \$2,161.44. Councilman Martin seconded, all favored, none opposed, motion carried.

On a personal note, Chief Reeves shared with all attending, that his daughter will be graduating, participated in Honors Day today and with a 32 on ACT, she has a full ride to University of Alabama.

# STREETS/PUBLIC WORKS

Mayor Criswell stated that the Public Works Department has a new tractor. It is on display out front tonight. Wayne is excited to have his new tractor. Public Works is interviewing another man and that will give 4 employees with Public Works Dept.

## **BUILDING INSPECTOR**

Don Moss stated that the city needs to adopt the 2018 Building Code. Attorney Mims will draft an ordinance for this. Mr. Moss will get the information as the new ordinance will repeal the old one.

# **MAYOR'S DISCUSSION**

Mayor Criswell reported that one of our citizens, Bo Myers, had a stroke recently. His mom, Gloria Myers gave an update on Bo's condition.

Mayor Criswell reported that his Sister-in-Law (Judy's sister) had a stroke, as well. She has extensive damage and is now in Crown Place. She was the payroll clerk at UOP (Union Carbide) for many years.
