Ms. Howze came asking for Lister Lane to be maintained by the city. Ms. Howze
stated that she wanted Lister Lane put on the Pay-As-You-Go and have it paved.
She no longer wants gravel-she wants it paved. Attorney Mims stated that we
will meet with the county attorney and if it is indeed a public road, we will create
a resolution to legally take over the road and maintain it, but we will need proof

that it is indeed, a public road. Mayor Criswell stated that we cannot use public funds to maintain a private road. Mayor Criswell advised Ms. Howze that we put roads on the P-A-Y-G, but it is up to the county which ones are paved. Both the Mayor and City Attorney agreed to meet with Ms. Howze after the meeting, but she stated she could not stay as she has Bible study. Attorney Mims will bring back to next meeting the results of the meeting with the county attorney.

- 3. Councilwoman Greene made a motion to allow Terry Foster to use the Creola Senior Center for his Hunter Education Class on 9/21/2019 8am-5pm. seconded by Councilwoman Moss, all favored, none opposed, motion carried.
- 4. Councilwoman Greene presented a quote of \$ 1,484.97 (\$1,399.00 ea. + 85.97 freight = \$1,484.97 for baby swings for park. The swings are for one parent + toddler. Councilwoman Moss stated that we need to finish the walking trail and we will get a quote on concrete from Sam Sanders for the trail. A motion was made by Councilwoman Green to table the swings until next meeting as we need to get a quote for completing the walking trail for the park seconded by

- Councilwoman Moss, all favored, none opposed, motion carried. The funds for these projects are from LIP donation.
- 5. Chief Kirkland asked for 7 radar units for the police department so a unit can be placed in each patrol car. The total for the 7 units (\$900.00 each) including freight (\$70.00) = \$6,370.00. A motion was made by Councilman Walker to purchase the 7 units, seconded by Councilman Hadaway. The officers will receive training & certification for the radar before using.

# STREETS/PUBLIC WORKS

Mayor Criswell stated that the Public Works Department had a tough week. Wyatt Watson's grandfather passed away this past weekend and his Dad is in ICU at Springhill Memorial. Anthony Walker's Dad passed away last night. Wayne and Austin have been cutting on a rotating schedule. They have cut Jackson Rd. and Radcliff Rd. Three trees were down on Sheffield Circle, Lister Dairy Rd., and Hardy Dr. They were 2-3' in diameter, had to be cut up w/ chain saw and hauled to the burn pile. Mayor Criswell stated that we are still having a lot of vandalism in Crenshaw Park and in the city park bathrooms. We pick-up trash by the tons throughout the city. Our administrator, Marcy Brown's husband, helped Wayne w/ welding the bleachers at the park.

### BUILDING INSPECTOR

Don Moss reported that we have a new set of plans from SSAB, the trailer storage is ready to pour the slab, Dollar General has permits, contractors have permits, as well. The slab will be poured soon. We have plans for 2 new homes in Creola.

## **MAYOR'S DISCUSSION**

Mayor Criswell reported that Steve Platt w/ Platt's Grocery will be retiring July 25, 2019. Mr. Platt is 72 years old and wants to retire. Another factor for closing: he is not very competitive w/ Dollar General, the building has age and his meat market has health issues with the health dept. These issues helped him decide to retire. Mayor Criswell stated that we have been contacted by several individuals wanting to open a grocery store. Mayor Criswell stated that we appreciate Mr. Platt and his service to our community for all these years. Mayor Criswell wanted to recognize Mr. Platt at one of our meetings, but Mr. Platt declined.

Mayor Criswell stated that we have an Amnesty program in place for August 12 thru August 16, 2019 at City Hall 8am-5pm for anyone wishing to pay fines without coming to court.

Mayor Criswell stated that we now have the MIS Program in place. At the ALM Conference, it was reported a total of \$8M + has been collected in Alabama thru MIS. If you get a ticket and decide not to pay it, your social security number and driver's license number will be attached to your Alabama State Income tax and it will be deducted from your refund or added to the balance you owe. These funds will be sent back to the City of Creola.

Mayor Criswell reported that our council meetings are held the 2<sup>nd</sup> and 4<sup>th</sup> Thursday of each month and he would love to see this crowd tonight at all our council meetings. This is your City. We are here for you. Mayor Criswell thanked all for attending.
