

Minutes of the City of Creola Council Meeting Thursday, December 23, 2021 Creola City 9, 2021Hall Meeting 5:00 P.M.

The regular council meeting was called to order by Mayor Don Nelson at 6:00 p.m. We were led in prayer by Mayor Nelson. The Pledge of Allegiance was led by Mayor Nelson. Roll call was taken by City Clerk Marcy Brown. Present at the meeting was Mayor Nelson, Cody Chambless, Kendal Hadaway, Wendy Lynch, and Harold Parmer. Council Member Mark Howell was absent. Also present was City Attorney, Daniel Mims.

Item #5 -Approval of the Minutes -

Approval of the Minutes - The minutes of the December 9, 2021, regular meeting minutes were reviewed. A motion was made by Mr. Parmer to accept the minutes, as written. The motion was seconded by Mayor Nelson. All in favor and the motion was carried.

Item #6- Financials/Bill List-

Mayor Nelson gave an update on the finances and bank balances. Mr. Chambless made a motion to approve the financials as presented. Mrs. Lynch seconded the motion. All in favor and the motion was carried.

Mr. Chambless made a motion to approve the bill list in the amount of \$5888.99 dated December 24, 2021, as presented. Mrs. Lynch seconded the motion.

Mr. Hadaway made a motion to table the Avenue Contract for the collection of the sales tax until they've had a chance to review it. Mr. Chambless seconded the motion. All in favor and the motion was carried.

Item #7 - Departmental Reports -

Police Dept. - Mr. Hadaway was going to contact CTS about changing the code for the Creola Police Department as well as adding a greater storage capacity for the cameras and extending the storage capacity to at least a month. Chief Hammond talked about getting a new taser system for all the officers. More information will be gathered to present to the mayor and council.

Sail Center - No report given.

Fire Dept. – Chief Moye stated that he needed some new fire hoses. Mr. Kendal made a motion to approve phase I for the purchase of new fire hose for squad 10 and engine #2 in the amount of \$3386. Mr. Parmer seconded the motion. All in favor and the motion was carried.

Mr. Chambless made a motion to approve the new appointed officers for the Creola fire department. Mr. Parmer seconded the motion. All in favor, except for Mr. Hadaway who is an officer, and the motion was carried.

Public Works Department - No report given

All in favor and the motion was carried.

- e. Amy Grimes Transfer to Satsuma Mr. Hadaway made a motion to approve the transfer of Amy Grimes to the City of Satsuma. Mayor Nelson seconded the motion. All in favor and the motion was carried.
