We still have the grant for 1.5 million for a signal light on Highway 43 and Mrs. Ludgood has committed to giving us the matching funds of \$300,000. We are getting 1 million from the GOMESA grant for recreational use only. The City of Creola wrote a \$15,000 grant for the Creola Cemetery for new fencing.
