

Minutes of the City of Creola Council Meeting Thursday, June 26, 2025 Creola City Hall Meeting 6:00 P.M.

The Council of the City of Creola, Alabama, met in the Creola City Hall at 5:30 p.m. A workshop was held before the Council Meeting, at 5:30 p.m. Present at the meeting were Mark Howell, Harold Parmer, James Brown, Wendy Lynch, Kendall Hadaway, and Mayor Don Nelson. Items that were discussed were:

The regular council meeting was called to order by Mayor Don Nelson at 6:00 p.m. We were led in prayer by Mr. Bil Chambers. The Pledge of Allegiance was led by Mayor Don Nelson.

Rollcall was taken by City Clerk Marcy Brown. Present at the meeting were Mark Howell, Harold Parmer, James Brown, Wendy Lynch, and Kendal Hadaway, and Mayor Nelson. City Attorney Danny Mims was present.

## Item #5 -Approval of the Minutes -

The minutes of the June 12, 2025, meeting were reviewed. Mr. Parmer made a motion to accept the minutes of June 12, 2025. Mr. Brown seconded the motion. All in favor and the motion was carried.

### Item #6- Financials/Bill List-

The bills were discussed. Mr. Parmer made a motion to accept the bill list for June 26, 2025, as presented. Mrs. Lynch seconded the motion. All in favor and the motion was carried.

The financials were discussed. If anyone would like to see the reports, they are welcome to stop by the city hall. Bank balances were presented. Mr. Brown made a motion to accept the financials as presented for June 26, 2025. Mrs. Lynch seconded the motion. All in favor and the motion was carried.

## Item #7 - Departmental Reports -

**Police Dept.-** Chief Stringer stated that he needs vehicles for his department. Two employees are heading to the Mobile Police Academy on Mondy, June 30, 2025. There are plumbing issues at the police department that need corrected before moving back in.

Mr. Howell made a motion to allow Herring Plumbing to install 3 new commodes at a cost of \$565 each and to also replace the 2 grinder pumps at a cost of \$5,000. Mr. Parmer seconded the motion. All in favor and the motion was carried.

Fire Dept. – Mr. Hadaway stated that they needed to purchase six (6) 5 gallons of foam for the fire department. Mr. Hadaway made the motion to purchase six (6) five-gallon pails of foam at a cost of \$858.00. Mr. Parmer seconded the motion. All in favor and the motion was carried.

Mr. Hadaway made a motion to purchase fire badges at a cost of \$1,414.00. Mrs. Lynch seconded the motion. All in favor and the motion was carried.

Park Dept. – All is going well with the preparations for the 4<sup>th</sup> of July.

Mrs. Lynch seconded the motion. All in favor and the motion was carried.



- g. Resolution 2025 008 Resolution for Each Officer Elected Without Opposition Council Member Place 5 Mark Howell Mr. Hadaway made a motion to adopt Resolution 2025 005 Resolution for Each Officer Elected Without Opposition, Council Member Place 5 Mark Howell. Mrs. Lynch seconded the motion. All in favor and the motion was carried.
- h. Security Camera for City Hall and Veterans Memorial A total security system would cost about \$16,000. However, we can grow the system as we need. Using just 5 cameras at this time to cover the door entrances and veteran's memorial would cost \$5,980.
  - Mr. Parmer made a motion to purchase the security system at a cost of \$5,980 with the ability to grow it in the future. Mr. Hadaway seconded the motion. All in favor and the motion was carried.
- i. 4<sup>th</sup> of July –Everyone is lined up for the upcoming 4<sup>th</sup> of July celebration.
- **j.** Gazebo Flooring Mr. Parmer will have someone come give a quote for putting down a floor covering on the gazebo.
- **k.** Police Ford Explorer Mr. Parmer made a motion to purchase the 2020 Flord Explorer if there was a warranty, spending up to \$29,900, Mr. Howell seconded the motion. All in favor and the motion was carried.
  - Mr. Howell made a motion to purchase the 2022 Ford Explorer if the 2020 model was no longer available, as long as the warranty was still available. Mr. Hadaway seconded the motion. All in favor and the motion carried.
- **l.** Christmas Tree Mrs. Lynch made a motion to purchase a majestic mount pine tree growth from Christmas Designer to grow the tree from a 14 ft. to a 16 ft at a cost of \$2,577. Mr. Parmer seconded the motion. All in favor and the motion was carried.
- m. William Fire apparatus Mr. Hadaway made a motion to set up an account with Williams Fire Apparatus for the fire department. Mr. Howell seconded the motion. All in favor and the motion was carried.
- **n.** Fire Chief Position Mr. Hadaway made a motion to hire a full-time fire chief at a cost of \$66,600. Mayor Nelson seconded the motion.
  - Rollcall Vote: Mark Howell No, Harold Parmer No, James Brown Yes, Wendy Lynch No, Kendal Hadaway Yes, Mayor Nelson Yes. Motion failed due to no majority vote.

After voting, Mr. Parmer said that more needed to be worked out regarding the pay, so until this is done, everything is on hold.

# **Item #9 Mayor Comments**

Discussion is still being made regarding the Fire Chief position. Mayor Nelson wanted the council to think about readdressing the business license ordinance to see if we need to make any changes.

Service Masters completed their work and now we are waiting for an air quality test.

Mr. Brown made a motion to adjourn. Mrs. Lynch seconded it. All in favor and the motion was carried. The meeting was adjourned at 7:28 p.m.
