

### c. Senior Center Flower Beds - \$300

#### d. Fire Truck Batteries

Mr. Hadaway made a motion to purchase six (6) new batteries for engine one for \$882.00. Mr. Howell seconded the motion. All in favor, and the motion was carried.

Mr. Hadaway states they had to do an emergency tire replacement last week. Mr. Hadaway made a motion to purchase two new tires for the front of squad 10 for \$679.46 each. The tire, labor, and service fee will come out of the fire fund. Mr. Parmer seconded the motion. All in favor, and the motion was carried.

## **Item #9 Mayor Comments**

The mayor states that he and Chief Stringer met with Mr. Cooper with ALDOT, and they would have a plan and price ready by November 5, 2025.

The mayor states he has three (3) bids that were opened at 6:10 pm for the tree trimming of low-hanging limbs and to haul off debris from Dead Lake Rd and Sheffield Cir.

- 1. Reed's Tree Service bid amount \$6900.50
- 2. Clancy Tree Service bid amount \$5200.00
- 3. Hammoo Tree Service bid amount \$15200.00

Mr. Howell made a motion to allow Clancy Tree Service to do the work. Mr. Parmer seconded the motion. All in favor, and the motion was carried.

Mr. Mims, the attorney, advises to have on record their liability insurance to cover the city in case something happens.

The mayor states he is talking to the county about getting a proposal for some side-cutter work to be done. Mr. Mims, the attorney, states that if it is coming out of the gas tax funds to look into the different restrictions on how gas tax funds can be used, requiring careful consideration before allocation.

The mayor states that there is an event (Charlie Moye's retirement gathering) across the street, and all are invited.

Mr. Parmer made a motion to adjourn. Mr. Nelson seconded it. All in favor, and the motion was carried. The meeting was adjourned at 6:15 p.m.
